Gordon Morris Bakken is Professor of History at California State University, Fullerton, and is author of five books and numerous articles and review essays on western American legal history. His most recent major publication is *Practicing Law in Frontier California*, issued in 1991 by the University of Nebraska Press. He is vice president of the California Supreme Court Historical Society and is principally responsible for the Society's long-term program for recording oral histories of justices and other figures important in California's modern judicial and legal history.

Ben Field is a deputy district attorney in Santa Clara County. A graduate of Columbia College in Columbia University and of Boalt Hall School of Law, UC Berkeley, he is also a candidate for the doctorate in UC Berkeley's history department. His previous published work has appeared in the *Santa Clara Law Review*.

Christian G. Fritz is Professor of Law, University of New Mexico. He is a doctoral graduate in history of UC Berkeley and holds the J.D. from the Hastings College of the Law. An authority on 19th century California legal history, he has published numerous articles, including a study of the 1849 state constitution that appeared in a *Hastings Constitutional Law Quarterly* symposium. Fritz is also author of *Federal Justice in California: The Court of Ogden Hoffman, 1851-1891* (University of Nebraska Press, 1991).

Sally M. Furay is professor of law and English in the University of San Diego. She holds the J.D. and Ph.D. degrees from Stanford University, and has served as the vice president and provost of the University of San Diego. One of her special research interests is the history of gender issues in California law.

William Gallagher is a graduate of the UCLA Law School and holds the Ph.D. degree from UC Berkeley. He also did advanced study in sociology at the University of Chicago. Dr. Gallagher's recent writings have centered on the history of California courts and on the history of the state bar's disciplinary procedures and their effectiveness.

Stephen Gillespie holds the bachelor's and J.D. degrees from UC Berkeley and is presently a judicial clerk in the chambers of Judge John Noonan on the Ninth Judicial Circuit Court of Appeals. He is also completing a doctorate in the Jurisprudence and Social Policy Program, UC Berkeley, with a specialization in legal history.

The Hon. **Robert Kroninger** has served as judge on the municipal court bench, Oakland-Piedmont, and then as judge in the Superior Court, Alameda County. A graduate of Boalt Hall School of Law, UC Berkeley, he was a clerk during 1948-50 for Chief Justice Phil S. Gibson and was in private practice in Oakland prior to entering judicial service. Since retirement from the bench in 1984, he has remained active in private judging.

Charles McClain is lecturer in law and vice chair of the Jurisprudence and Social Policy Program, Boalt Hall School of Law, UC Berkeley. He also is coordinator of the school's undergraduate major program in Legal Studies. A doctoral graduate in history of Stanford University, he holds the J.D. from the Hastings College of the Law. He has been a National Endowment for the Humanities Fellow and is author of *In Search of Equality: The Chinese Struggle against Discrimination in Nineteenth-Century America* (University of California Press, 1994) and of articles in *Western Legal History* and other journals.

Charles W. McCurdy is Associate Professor of History and Law, University of Virginia. He holds the doctorate in history from UC San Diego, and he held a postdoctoral appointment in the Yale Law School prior to joining the Virginia faculty. McCurdy has written extensively on 19th century constitutional jurisprudence, including several studies of Justice Stephen Field, and he is coauthor of *The Fields and the Law* (1986). His writings have won the Cole Prize of the Economic History Association and the Pelzer Award of the Organization of American Historians. He has been a Guggenheim Fellow and recently won a distinguished teaching award from the University of Virginia.

Harry N. Scheiber is the Stefan Riesenfeld Professor of Law, Boalt Hall School of Law, and Chair of the Academic Senate, UC Berkeley. He is a member of the faculty for Boalt Hall's multidisciplinary doctoral pro-

gram in Jurisprudence and Social Policy. Editor of this *YEARBOOK*, he has written extensively on American legal history and on constitutional issues in journals of law, history, and social science. Among his books are *Ohio Canal Era* (Ohio University Press, second ed. 1987), *Federalism and the Judicial Mind* (editor) (IGS Press, 1993), and *American Law and the Constitutional Order* (coedited with Lawrence Friedman) (Harvard University Press, 1987). He has been a Guggenheim Fellow and a Distinguished Fulbright Lecturer to Australia.

Molly Selvin is a member of the *Los Angeles Times* editorial board. She holds the doctorate in American history from UC San Diego and did postdoctoral legal studies at Harvard Law School. Dr. Selvin's historical publications include articles in the *Wisconsin Law Review* and in *Law and Contemporary Problems*; and a book (with coauthor Patricia Ebener), *Managing the Unmanageable: A History of Civil Delay in the Los Angeles Superior Court* (RAND Corp., 1984).

Amy Toro is an advanced doctoral student specializing in legal history in the UC Berkeley Jurisprudence and Social Policy Program, and also is completing the J.D. at Boalt Hall. A graduate of the University of Virginia, she is associate editor of the book *Federalism and the Judicial Mind* (IGS Press, 1993) and is currently collaborating on a study of the contemporary California judiciary and constitutional reform.
